Dear Ciar,

As per ALAB's request to the SFPA under of s.47(1)(a) of the Fisheries Amendment Act 1997 (as amended), SFPA are now providing Gatherers Documents where available in respect of AP5/2019, AP6/2019, AP7/2019, AP8/2019 and AP9/2019.

The documents in our possession relate to two Gatherers. If you require documents solely in relation to the Appellant then you might kindly advise us of the identity of the Appellant and we will only furnish those documents that relate to that Gatherer/Appellant (if he/she is indeed one of the Gatherers in question). If you require all Gatherer's documents relating to Killary Harbour then you might just confirm same.

The Gatherers documents concerned contain personal information including commercially sensitive information as defined in the Data Protection Acts. We intend to send this information in unredacted format on the basis of the said request under s.47(1) which imposes a legal obligation on the SFPA to furnish the documents and we presume that same are required in unredacted format for the purposes of the deliberations of ALAB being deliberations occurring in the context of in contemplation of an administrative or out-of-court procedure.

As you mentioned that the Gatherers Documents (or information contained therein) will be made publicly available once you have concluded the process, we would request in advance of publication that you contact us and we can indicate which sections of the Gatherers documents will need to be redacted so we all meet our Data Protection obligations.

In respect of your original request please note that the SFPA in accordance with our Data Retention Policy does not keep Gatherers documents indefinitely and therefore any Gatherers Documents prior to 2015 are no longer held by us. In addition, since the introduction of GDPR in May 2018 the SFPA no longer routinely collects Gatherers Documents so some files may be incomplete for that reason.

We intend to share the documents by Next Cloud and a link will be forwarded to you and the password in separate emails.

If you require anything further, please let me know.
