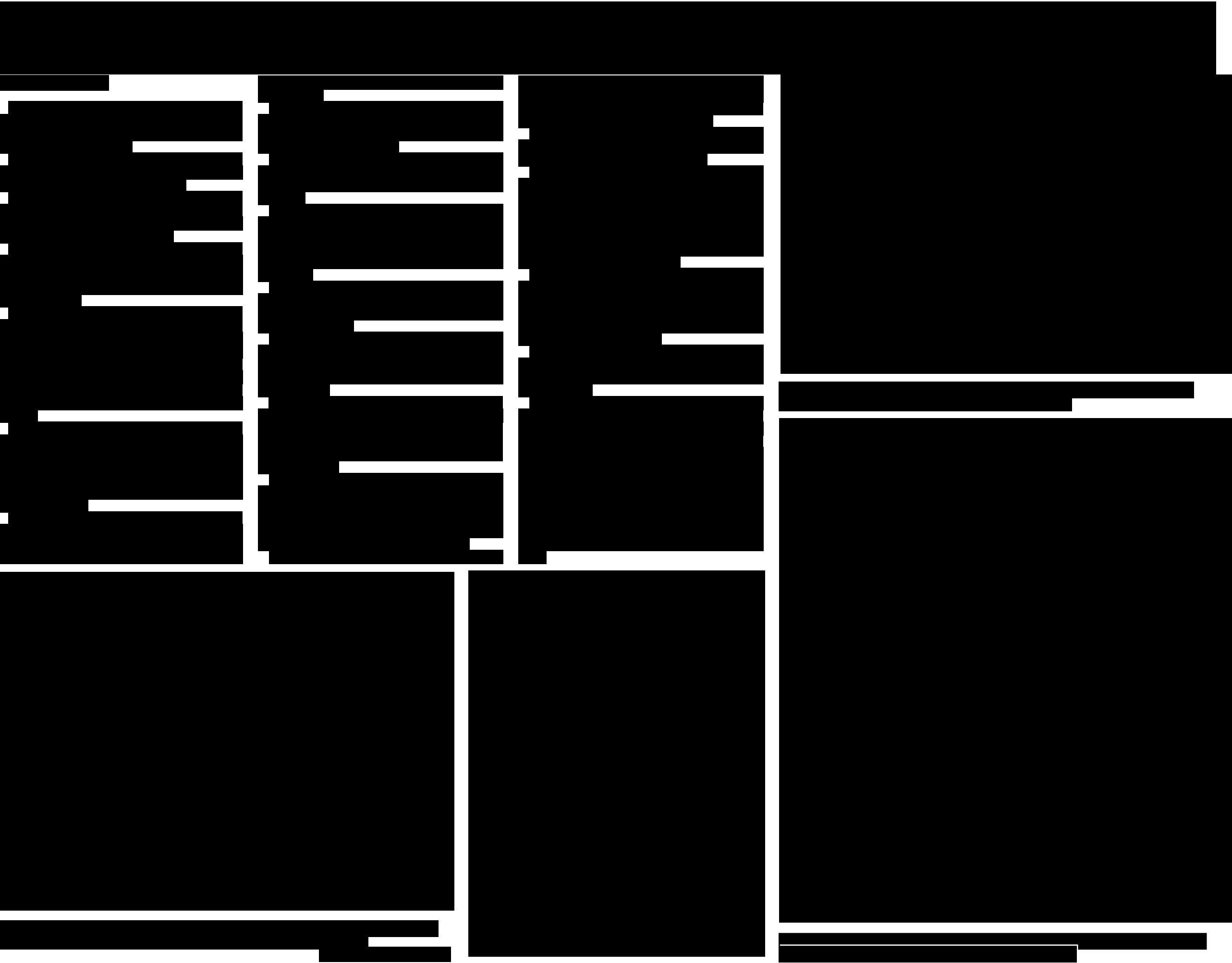

FISHERIES (AMENDMENT) ACT 1997 (NO. 23)
NOTICE OF DECISION RELATING TO AQUACULTURE LICENCE APPEAL

The Aquaculture Licences Appeals Board (ALAB) has made a determination dated 12 September 2025 on an appeal relating to the decision of the Minister for Agriculture, Food and the Marine made on 12 April 2019 to revoke a statutory entitlement to continue aquaculture operations at site T06/202 east of Deenish Island Co. Kerry as set out in the table below:
