With the conclusion of another year's work at the Aquaculture Licences Appeals Board, I am pleased, once again, to include my Chairman's Statement in this, the Board's 7th Annual Report.

This year saw a number of changes both at Board membership and secretariat level. Ms Ann Kissane, Secretary to the Board since November 2002, departed in August to take up a new appointment in the Department's Head Office. She was replaced by Ms. Carol Lodola, on a part-time basis. I know I speak on behalf of all the Board members in taking this opportunity to wish Ann every success in her new post and to thank her for her enormous contribution to the establishment and operation of the Board.

I also wish to thank Dr. Ann Quinn, Mr Michael Harte and Mrs Mary Nolan whose terms of office expired at the end of July 2004. They served on the Board at a particularly challenging and time consuming period due to the large number of appeals which came before the Board following its establishment. Considering

the part-time status of the Board, the number of determinations made by it during the early years bear testament to the unfailing commitment of all concerned. This year also saw the end of a one-year appointment period for three of the Board members on 31st December 2004, Mr. Mario Minehane, Mr. Sean Murphy and Mr. Lorcán Ó Cinnéide with the Minister re-appointing each member for a period of three years to 31st December 2007.

In December 2004, Mr Pat the Cope Gallagher, T.D., Marine Minister, announced the appointment of Mr Damien McDonald, Ms Karin Dubsky and Mary McMahon for a period of two years effective from 1st January 2005 to replace the outgoing members.

December 2004 also saw the departure of Mr Eugene Nixon who has served the Board as Technical Inspector since October 2000. I would like to take this opportunity, on behalf of the Board and secretariat to thank Mr Nixon for the excellent advice, which he has provided over the last number of years. I wish him the very best for the future.

I will now briefly turn to the Board's activities for 2004. This year saw an increase in the number of appeals received by the Board. Details of the appeals received are outlined on page 8 of the report.

In summary, the total number of appeals received was 21, representing 15 Ministerial licence decisions. However, there was a further one appeal awaiting decision from 2003, giving a total of 22 appeals for determination. I am pleased to say that by end 2004 there were only three appeals awaiting determination. Details of the determinations made in 2004 are outlined on pages 11 and 12 of the report.

As Chairman, I wish to acknowledge the work of the Board members and to thank them and also the secretariat for their continued support and dependable service throughout the year.

# AQUACULTURE LICENCES APPEALS BOARD (A.L.A.B)

The following is some general information regarding the Aquaculture Licences Appeals Board. However, to obtain an overall picture as to how the appeal process as well as the aquaculture licensing system operates, reference should be made to the Fisheries (Amendment) Act, 1997, Fisheries and Foreshore (Amendment) Act, 1998, Aquaculture (Licence Application) Regulations, 1998 and also to the most recently introduced legislation, the Fisheries (Amendment) Act, 2001.

## ESTABLISHMENT OF BOARD

The Aquaculture Licences Appeals Board was established on 17 June 1998 under Section 22 of the Fisheries (Amendment) Act, 1997. All Board members are engaged on a part-time basis.

## FUNCTION

The function of the Board is to provide an independent authority for the determination of appeals against decisions of the Minister for Communications, Marine and Natural Resources on aquaculture licence applications. A person aggrieved by a decision of the Minister on an aquaculture licence application, or by the revocation or amendment of an aquaculture licence, may make an appeal within one month of publication (in the case of a decision) or notification (in the case of revocation/amendment).

## STATUS

The Board is an independent body with its own funding provided for by the Oireachtas under *Section 36* of the Act.

## MEMBERSHIP OF BOARD

As provided for under Section 23 of the Fisheries (Amendment) Act, 1997, the Board consists of a Chairman and six other members. The Chairman, Mr. Conleth Bradley, a practising barrister, was appointed by the Government for a term of 5 years, effective from 17 July 2003.

Dr. Ann Quinn, the former Deputy Chairperson, served on the Board from 12th November, 2001 until 16th July, 2004.

Mrs Mary Nolan and Mr Michael Harte served on the Board from the time of its establishment until 16th July, 2004.

Mr Mario Minehane, Mr Sean Murphy and Mr Lorcán Ó Cinnéide have served on the Board since 4th December 2003. In December 2004, Mr Pat the Cope Gallagher, T.D., announced their reappointment, for a period of three years effective from 1st January 2005.

In December 2004, Mr Pat the Cope Gallagher, T.D., Marine Minister, announced the appointment of Mr Damien McDonald, Ms Karin Dubsky and Ms Mary McMahon for a period of two years effective from 1st January 2005 to replace the outgoing members.

## COMPOSITION OF BOARD

In accordance with *Section 23(3)* of the Act, the Minister for the Marine and Natural Resources made regulations prescribing not less than two organisations representative of each of the following groupings:

- (a) organisations concerned with the promotion of the development of aquaculture or representative of persons carrying on the business of developing aquaculture;
- (b) organisations concerned with the conservation, development and protection of wild fisheries;
- (c) organisations representative of persons whose professions or occupations relate to physical planning and development;
- (d) organisations representative of persons concerned with the protection and preservation of the environment and amenities;
- (e) organisations representative of persons concerned with the promotion of general economic development and
- (f) organisations representative of persons concerned with the promotion of community development.

## RESPONSIBILITIES

The main responsibilities and powers of the Board are set out below:

Under *Section 40(4)* of the Act, on receipt of an appeal by the Board and provided it is not withdrawn, the Board can determine the appeal by;

- a) confirming the decision or action of the Minister

- (b) determining the application for the licence as if the application had been made to the Board in the first instance or
- (c) in relation to the revocation or amendment of a licence, substituting its decision on the matter for that of the Minister;

Under *Sections 43 and 44* of the Act, the Board must send a copy of the notice of appeal to the Minister and to each other party to the appeal;

Under *Section 46* of the Act, the Board can request submissions or observations from parties or other persons who have already made submissions or observations to the Board in relation to an appeal, if, in the opinion of the Board and in the circumstances, it is in the interests of justice to do so;

Under *Section 47* of the Act, the Board can request documents, particulars or other information it considers necessary for the purpose of enabling it to determine an appeal;

Under *Section 49* of the Act, the Board has the absolute discretion to hold an oral hearing of an appeal;

Under *Section 56* of the Act, the Board shall ensure that appeals are dealt with and determined expeditiously and that all steps are taken to avoid unnecessary delays.

## CONSULTANTS AND ADVISERS

Under *Section 35* of the Act, the Board may engage such consultants or advisers as it considers necessary for the performance of its functions. Fees due to either, are paid by the Board out of moneys made available by the Oireachtas. Mr. Eugene Nixon served as Technical Inspector, from October 2000 to December 2004.

## SECRETARIAT

Under *Section 32* of the Act, an officer of the Minister who is an established civil servant and who is seconded to the Board for that purpose, either on a whole-time or part-time basis, shall act as Secretary to the Board.

## APPEALS RECEIVED

In 2004 the Board received a total of 21 appeals, representing an increase of 300% on the level of appeals received in 2003.

In addition to the 21 received in 2004, there was one other appeal awaiting decision from 2003, giving a total of 22 appeals for determination. The 7 appeals received represented 15 Ministerial licence decisions from a total of 39 Ministerial decisions made in 2004, which were subject to appeal.

Eighteen of the 21 appeals received in 2004 were in relation to the granting of licences for the cultivation of mussels, while two related to oysters and one to rainbow trout.

## JUDICIAL REVIEW

In accordance with Section 73 of the Fisheries (Amendment) Act, 1997, a person can apply for judicial review of determinations of the Board by way of an application for judicial review, provided it is made within the period of three months commencing on the date on which the determination was made.

There was one application for Judicial review received in 2004 and the details are as follows:

Application made by third party, on 24th November 2004, in relation to a Board decision dated 25th August 2004 in respect of the granting of an aquaculture licence to Alex McCarthy Shellfish for the bottom cultivation of mussels in Carlingford Lough, Co.Louth.

This case is waiting a date to be assigned for hearing.

# BOARD'S ACTIVITIES IN 2004

## SUMMARY OF DETERMINATIONS

The Board made a total of 14 determinations in 2004.

This resulted in the granting of 12 aquaculture licences with revised conditions, all in respect of mussels. The Board also upheld one appeal by refusing to grant an aquaculture licence for the cultivation of salmon. In the case of one appeal against the Minister's decision to refuse to grant a licence for the cultivation of mussels the Board confirmed the decision of the Minister.

During 2004, the total area licensed by the Board for mussels was 544.9 ha.

## DETAILS OF APPEALS RECEIVED AND DETERMINATIONS MADE IN 2004

Under *Section 40(4)* of the Fisheries (Amendment) Act, 1997, the Board, in determining the appeals has the option of:

- (i) confirming the decision of the Minister to grant or refuse a licence or
- (ii) determining and issuing its own aquaculture licence as if the application for the licence had been made to the Board in the first instance.

Where the Board determined that it wished to alter the terms or conditions of a licence decision granted by the Minister, it did so by issuing its own licence with additional or altered terms and conditions.



# STATEMENT ON INTERNAL FINANCIAL CONTROLS

The Board acknowledges its responsibility for the Aquaculture Licences Appeals Board's system of financial control. It also recognises that any system of financial control can only give reasonable and not absolute assurance against any material errors. The internal financial controls in operation by the Board during 2004 are detailed as follows:

- The Board Secretariat is familiar with financial control procedures, including procurement, debtor and creditor procedures.
- All invoices are checked and authorised by the Secretary before payment.
- All cheques are signed by the Secretary with an additional signature from one other Board member required.
- Expenditure details are forwarded to Finance Unit of the Department on a monthly basis.
- The Board has engaged a firm of Accountants to prepare Financial Statements for the annual audit of Board income and expenditure.
- Apart from the legal and professional fees, the bulk of the Board expenditure is incurred on staff salaries, Board Members' remuneration and travel and subsistence. Staff salaries and travel and subsistence claims are paid by the Department, which recoups this expenditure from the Board. With effect from October 2004 travel and subsistence claims for Board members are paid locally. An external payroll company has been engaged by the Board to deal with Board Members' remuneration.

## ANNUAL REVIEW OF CONTROLS

- The Board did not carry out a formal review of its financial controls during 2004. However the Board engaged a firm of Accountants in 2004 to provide an internal audit service to the Board. Neither review was finalised in respect of 2004; however, the Board expect the final review to be completed before the end of 2005.

# REPORT OF THE COMPTROLLER AND AUDITOR GENERAL

## for presentation to the Houses of the Oireachtas

I have audited the financial statements on pages 5 to 10 under Section 37 of the Fisheries (Amendment) Act, 1997.

### **RESPECTIVE RESPONSIBILITIES OF THE MEMBERS OF THE BOARD AND THE COMPTROLLER AND AUDITOR GENERAL**

The accounting responsibilities of the Members of the Board are set out on page 2. It is my responsibility, based on my audit, to form an independent opinion on the financial statements presented to me and to report on them.

I review whether the statement on the system of internal financial control on page 3 reflects the Board's compliance with applicable guidance on corporate governance and report any material instance where it does not do so, or if the statement is misleading or inconsistent with other information of which I am aware from my audit of the financial statements.

### **BASIS OF AUDIT OPINION**

In the exercise of my function as Comptroller and Auditor General, I conducted my audit of the financial statements in accordance with auditing standards issued by the Auditing Practices Board and by reference to the special considerations which attach to State bodies in relation to their management and operation.

An audit includes examination, on a test basis, of evidence relevant to the amounts and disclosures in the financial statements. It also includes an assessment of the significant estimates and judgments made in the preparation of the financial statements, and of whether the accounting policies are appropriate to the Board's circumstances, consistently applied and adequately disclosed.

I planned and performed my audit so as to obtain all the information and explanations that I considered necessary to provide me with sufficient evidence to give reasonable assurance that the financial statements are free from material misstatement whether caused by fraud or other irregularity or error. In forming my opinion I also evaluated the overall adequacy of the presentation of information in the financial statements.

# STATEMENT ON ACCOUNTING POLICIES

## 1. GENERAL

The Aquaculture Licences Appeals Board was established on 17 June 1998 under Section 22 of the Fisheries (Amendment) Act, 1997. The Board deals with Appeals against decisions of the Minister relating to aquaculture licences.

## 2. BASIS OF ACCOUNTING

The financial statements are prepared under the accruals method of accounting, except as indicated below, and in accordance with generally accepted accounting principles under the historical cost convention. Financial reporting standards recommended by the recognised accountancy bodies are adopted, as they become operative.

## 3. INCOME

Appeal Fees are recognised in the Financial Statements on a receipts basis.

Oireachtas Grants received from the Department of Communications, Marine and Natural Resources are recognised in the accounts on a cash receipts basis.

## 4. CAPITAL ACCOUNT

The Capital Account represents the unamortised value of income used for capital purposes.

## 5. DEPRECIATION

The cost or valuation of tangible fixed assets, including leased assets, is written off by equal instalments as follows:-

Office equipment	3 years

## 6. SUPERANNUATION

Staff of the Board are seconded from the Department of Communications, Marine and Natural Resources and are covered by the Department's pension arrangements. The Board does not operate pension schemes.


