Outline ground for appeal:

- The location of the proposed site is on a sandbank away from the mudflats, therefore to give shorebirds a natural habitat and will not impact on bird population.
- If licenses are granted it would have a positive effect on the local economy.
- I would minimize the density of license application to avoid further risk being posed to the seston depletion, thus this would not interfere with the capacity of the harbour.
- Oysters are filter feeder which results in cleaner water.
- Site is located away from Navigational Channels.
- Site is located East of the Castlemaine Harbour and is <u>not</u> located near any recreational area.
