Extracts from Act

40.—(1) A person aggrieved by a decision of the Minister on an application for an aquaculture licence or by the revocation or amendment of an aquaculture licence may, before the expiration of a period of one month beginning on the date of publication in accordance with this Act of that decision, or the notification to the person of the revocation or amendment, appeal to the Board against the decision, revocation or amendment, by serving on the Board a notice of appeal.

(2) A notice of appeal shall be served-

(a) by sending it by registered post to the Board,

(b) by leaving it at the office of the Board, during normal office hours, with a person who is apparently an employee of the Board, or

(c) by such other means as may be prescribed.

(3) The Board shall not consider an appeal notice of which is received by it later than the expiration of the period referred to in subsection (1)

41.-(1) For an appeal under section 40 to be valid, the notice of appeal shall-

(a) be in writing,

(b) state the name and address of the appellant,

(c) state the subject matter of the appeal,

SUBMISSIONS REGARDING REFUSAL TO GRANT LICENCE T12/405A

As per my previous letter of objection to T12/405A, I Sarah Gildea am reaffirming my serious concerns regarding any consideration to issue Aquaculture and Foreshore licence's in Loughros Mor Bay, Ardara, Co. Donegal and the arguments on which my objections are based.

This bay and the beaches associated with Loughros Mor Bay are a public amenity. As a horse owner and breeder, I along with several other locals, have been using this amenity to train and exercise horses for over twenty years. It is of note that all others using Loughros Mor Bay to do same have already submitted objections to T12/405A through the initial Department of Agriculture Food and the Marine public consultation process.

Born in Derryness, into a farming background, I have invested heavily in establishing my equine interests and career through education (BSc Equine Science at the University of Limerick), years spent selectively breeding good bloodlines and financially in building stables and equine training facilities. I recently made significant capital investment in the business through the procurement of lands at Folio DL57915F which is located adjacent to Ranny Point South and through this business continue to have an ongoing requirement for ancillary services e.g. agricultural contractors, feed suppliers, veterinary practitioners and farriers providing local employment in the area.

While I acknowledge that Loughros Mor Bay contains a total area of 1500 hectares, only a small portion of this bay which contains stable hard substrate is suitable for exercising and training horses. Any oyster trestle or bag deployment along with the associated equipment and debris in such an area will pose a significant risk to my horse's safety and welfare and to I in turn as a rider. Furthermore, the proposal of an alternative access route at Ranny Point South and the intensification of oyster trestles in this region would render my land located at Folio DL57915F completely inaccessible from the foreshore. Contrary to the facts stated in the ALAB appeal associated with T12/405A the issuing of Aquaculture and Foreshore licence's in Loughros Mor Bay, Ardara, Co. Donegal would significantly impact my use of this public amenity and render my equestrian business completely unsustainable with immediate effect and I will undertake all means required to ensure that my entitlement to continue to use this public amenity in a safe manner is not displaced in any way nor is the welfare of my horses compromised. Applicant T12/405 proposes minimum employment prospects should licencing be granted. The displacement of existing agricultural businesses with intensive oyster farming is in complete contradiction to the EU and the Irish Government led National Reserve and Young Farmer Schemes encouraging and facilitating generational reserve through the entrance of young and well-educated persons into the farming and agricultural sectors.

The significant effort required by local residents to ascertain and provide justification for their genuine reasons for concern regarding the licencing of oyster farms in Loughros Mor Bay defies belief. As does the labelling of anyone with such objection as nimby with little consideration given to the significant financial expense which is required by any member of the public who tries and protect their livelihood and the livelihood of future generations to come. As a Scientist, qualified to PhD level with >20 scientific papers published in peer reviewed scientific journals, I welcome all further input from specialised experts in the areas of Food Safety, Tourism, Economics, Ornithology, Wildlife, endangered species, Archaeology etc. and look forward to their endorsement of the decision by Mr Creed and the Department of Agriculture, Food and the Marine in the refusal of all Aquaculture and Foreshore licence's in Loughros Mor Bay.
