It is stated in Paragraph A that the "substrate is unsuitable With areas of uneven profile. This is not the case with the Siles we are now applying for. These are 1/2/531 A and 1/2/532A. If we thought any of the concerns Raised would become problems we would not be interested in applying for the sites. I would like to ask what if any scientific study has been done to prove any of the concerns Raised in Paragraphs ABORC.
